- 7 some background information very briefly. You were employed

- 12 period of time?
- 13 A Yes.
- 14 Q All right. During that entire period of time?
- 15 A While at the West End Station?

- 18 officer.
- 19 Q All right. And after the mid '80s, what were you?
- 20 A Went into public affairs and then detective.

- 21 Mr. Beltz' name appears -- and this is the reason he's here.
- 22 I can ask him that. If that's the only reason he's here,
- 23 I'll ask him one question and we'll have him out of here.
- 24 He is the gentleman that we're trying to figure out the
- 25 source of the information for which -- excuse me. He is the

- 1 gentleman for whom we're trying to find out the source of 2 the information at 12:48 on June the 5th regarding the 3 identification of the three individuals.
- MS. WILKENS: Well, then I guess counsel could ask that instead of other questions about the crime scene.
- THE COURT: Well, it's his -- it's his strategy.
 You may proceed.
- 8 MR. ALEXANDER: This is just foundational to lead 9 up to that very entry log.
- 10 BY MR. ALEXANDER:
- 11 Q Let me ask you one question, sir. Did you have any
- 12 involvement as a -- in 1983 in connection with employees or
- 13 patrons of the Canyon Corral Bar?
- 14 A I'm sorry. Could you repeat that?
- 15 Q Yes. Do you know what the Canyon Corral Bar is?
- 16 A Yes, I do.
- 17 Q All right. Now, in connection -- well, withdraw that.
- 18 In connection with the Ryan/Hughes crimes, did you have any
- 19 involvement with regard to employees or patrons of the
- 20 Canyon Corral Bar?
- 21 A I would say no, but I would like to clarify that --
- 22 Q By all means.
- 23 A -- with a narrative.
- 24 Q Well, I don't want a narrative.
- 25 A I believe -- I believe --

- $\mathbb{L} \mid \mathbb{Q}$ Excuse me. Let me go by question --
- 2 A If you don't want a narrative, then I'd say no.
- 3 Q No, I do want to hear it, but I think we will need to
- 4 proceed by question and answer, and if I don't bring it out,

- THE COURT: The Court agrees.
- 7 MR. ALEXANDER: Thank you, your Honor.
- 8 BY MR. ALEXANDER:
- 9 Q All right. Did you interview with any persons who were
- 10 in the Canyon Corral Bar the late evening of January -- of
- 11 June the 4th or early morning of June the 5th, 1983?
- 12 A I don't recall that.
- 13 Q You don't recall doing that?
- 14 A No.
- 15 Q Okay. Without getting into a long narrative answer,
- 16 what, if any, involvement did you have in connection with
- 17 the Canyon Corral Bar?
- 18 A I may have been -- my unit may have been parked when I
- 19 got the call in the parking lot of the Canyon Corral Bar.
- 20|Q Okay. So when you got the call to go up to the Ryan
- 21 home on June the 5th at approximately 12:48, your patrol car
- 22 was in the parking lot of the Canyon Corral Bar, is that
- 23 correct?
- 24 A Yes. I may have been driving through the parking lot
- 25 or I may have been parked momentarily.

- 1 Q Okay. But at that point --
- $2 \mid A$ I can't recall because it -- and it's not my report,
- 3 and I'm having to rely completely on memory.
- 4 Q Okay.
- 5 A And I don't -- I don't believe -- I don't remember
- 6 whether I was parked, whether I was just passing through the
- 7 parking lot at that time.
- 8 Q All right. Is that the only connection with the Canyon
- 9 Corral Bar you think you may have had, that when you
- 10 received the call --
- 11 A Yes.
- 12 Q Excuse me. -- that when you received the call to go up
- 13 to the Ryan home, you just happened to be passing through
- 14 the parking lot or stationed in it or, you know, sitting in
- 15 it?
- 16 A Yes.
- 17 Q All right. Okay. Now, prior -- prior to receiving the
- 18 call, when you were wherever you were, including perhaps in
- 19 the parking lot of the Canyon Corral Bar, you had no
- 20 information about any crime being committed at -- at the
- 21 Ryan Home?
- 22 A No.
- 23 Q What I said is correct?
- 24 A Correct.
- 25 Q All right. Thank you. One of these days I'm going to

- 16 Q All right. Now, that Beltz in the right-hand column is
- 17 Paul Beltz, correct?
- 18 A Yes.
- 19 Q That's yourself?
- 20 A Yes.
- 21 Q All right. And you did receive a call on or about
- 22 12:48 on --
- 23 A Yes.
- 24 Q -- June the 5th to go up to 2951 English Road, correct?
- 25 A Correct.

- 1 Q All right. And can you tell by looking at this log who
- 2 you received the call from?
- 3 A Okay.
- 4 Q You're welcome to look back, indicate the people who
- 5 were on duty at that time at the station if that refreshes
- 6 your recollection, specifically on page five.
- 7 A I believe it was Simendich.
- THE COURT: Was -- pardon me?
- THE WITNESS: Simendich. That would be the third
- 10 name down in that list of names.
- 11 BY MR. ALEXANDER:
- 12 Q On page five?
- 13 A On page five.
- 14 Q That's Nancy Simendich?
- 15 A Yes.
- 16 Q Okay. Now, when you went up to the house, you were met
- 17 by Mr. Howey?
- 18 A Yes.
- 19 Q Okay. And who is Mr. Howey, if you recall?
- MS. WILKENS: Your Honor, I'm going to object on
- 21 403. He's going through everything he did at the crime
- 22 scene, and the focus is --
- THE COURT: Overruled for now.
- THE WITNESS: Mr. Howey is a resident of Old
- 25 English Road.

- 1 BY MR. ALEXANDER:
- 2|Q Okay.
- B|A His son was also a -- a victim inside the Ryan
- 4 residence.
- 5 Q You mean Mr. Hughes' son was a victim? I think you may
- 6 have --
- 7 A I'm sorry. Yes.
- 8 Q Okay. And but who is Mr. --
- 9 A Mr. Howey is a resident on Old English Road.
- 10 Q All right. And he was the person you spoke with?
- 11 A Yes.
- 12 Q Not Mr. Hughes, is that correct?
- 13 A Mr. Howey.
- 14 Q Is the person you spoke with when --
- 15 A Yes.
- 16 Q -- you went up there? All right. Now, I don't want
- 17 to -- I don't want you to tell me what you did in the house.
- 18 I'm not interested in that. But I just want to know how
- 19 many -- did you go into the house, the Ryan house?
- 20 A Oh, yes.
- 21 Q All right. And about how many minutes were you in the
- 22 house?
- 23 A I was in there a total -- because I was in there for a
- 24 while and then I was out, and then I went back in, so
- 25 probably a total of 30 minutes.

- 1 Q All right. And did Mr. -- did Detective Gilmore come?
- 2 A Sergeant Gilmore arrived.
- 3 Q Sergeant Gilmore, excuse me.
- 4 A Yes.
- 5 0 And he's from homicide?
- 6 A No.
- 7 Q What --
- 8 A He was the watch commander --
- 9 Q Okay.
- 10 A -- for that shift.
- 11 Q Did -- what -- and you spoke with him, correct?
- 12 A Yes.
- 13 Q Did he then ask you to do something?
- 14 A He asked me to secure the crime scene.
- 15 Q Okay. So you left the house after being in it two
- 16 times and you went and secured the crime scene, is that
- 17 correct?
- 18 A Yes.
- 19 Q All right. Now, directing your attention back to page
- 20 nine on --
- 21 A Of the log?
- 22 Q -- of the log, is any of the information provided in
- 23 the entry number 70 information that you related back to the
- 24 West End Station dispatch or desk officer?
- 25 A I let them -- I let the dispatcher know when I arrived.

- 1 Q All right. Where is that reflected?
- 2 A Where it says '97, '97. See where it -- fourth
- 3 sentence.
- 4 Q I see it, 12:51.
- 5 A On item 51, it says signed at 12:48. Ninety-seven
- 6 means arrived.
- 7 Q Yes.
- 8 A At 12:51.
- 9 Q And 12:51 you arrived three minutes after you received
- 10 the call?
- 11 A Yes.
- 12 Q So it's a good chance you were actually in the parking
- 13 lot of the Canyon Corral Bar which is close by, correct?
- 14 A Yes.
- 15 Q All right. All right. And 2P6, that's yourself,
- 16 correct?
- 17 A That was my -- that was my assignment, yes.
- 18 Q Okay.
- 19 A Area three in unit 2 Paul 6.
- 20 Q And you advised that there were four subjects dead on
- 21 arrival, correct? It says 2P6 advises four subjects dead on
- 22 arrival?
- 23 A Apparently at that time, yes.
- 24 Q All right.
- 25 A When I arrived, yes.

- 1 Q Well, they had -- sure, after you arrived, you informed
- 2 someone back at West End Station --
- 3 A Yes. Yes.
- 4 Q All right. And -- and you advised one juvenile
- 5 airlifted to Loma Linda, correct?
- 6 A No, I didn't advise airlift. That was the result of
- 7 paramedics arriving -- paramedics arriving and airlifting
- 8 one victim to Loma Linda.
- 9 Q So you did advise paramedics arrived?
- 10 A Yes.
- 11 Q And -- and one victim was airlifted to Loma Linda?
- 12 A Yes.
- 13 Q All right. And then suspect vehicle 1977 Buick station
- 14 wagon, white in color, you advised as to that information,
- 15 is that correct?
- 16 A Dispatch received that information from --
- 17 Q Excuse me. Let me repeat my question, okay, because I
- 18 think you're answering a different question, all right.
- 19 A Okay. Go ahead.
- 20 Q Yes. Sure. You advised suspect vehicle that 1977
- 21 Buick station wagon, white in color, wood sides, fog -- I
- 22 quess that's lights on front, and the license number,
- 23 occupied by three young males, period?
- MS. WILKENS: Objection. Leading.
- THE COURT: Sustained.

1 BY MR. ALEXANDER:

- 2 Q Did you advise as to that information that I just read?
- 3 A I don't recall whether I had supplied the information
- 4 to dispatch or whether dispatch upon hearing from the person
- 5 that initially made the call that there was suspect vehicle
- 6 in the area of that nature.
- 7 Q And the person who initially made the call was Mr.
- 8 Howey, correct, looking up at the top, Robert Howey, 627-
- 9 4729, advises of 245/187?
- 10 A Yes.
- 11 Q All right. So it was either you or Mr. Howey who
- 12 advised of that information?
- MS. WILKENS: Objection. Leading.
- 14 BY MR. ALEXANDER:
- 15 Q Is that your best recollection?
- 16 A It could have been me. It could have been him, yes.
- 17 Q All right. Now, you left the scene approximately --
- 18 your shift was over approximately 3:00 or 3:30 that day,
- 19 correct?
- 20 A Yes.
- 21 Q All right.
- 22 A But I did not leave the scene at 3:30.
- 23 0 You did not?
- 24 A No. I was there until --
- 25 Q Okay. When did you leave the scene?

- 1 A I don't think I left until 5:00 or 6:00 o'clock.
- 2 Q Okay. And the information "Vehicle belongs to the
- 3 victim, " that is also information that you or Mr. Howey
- 4 advised of, correct, to the best of your knowledge?
- 5 MS. WILKENS: Objection. Leading.
- ,6 THE COURT: Sustained. Just rephrase it.
- 7 BY MR. ALEXANDER:
- 8 Q Who -- who provided the information, "Vehicle belongs
- 9 to the victim?"
- 10 A I don't recall.
- 11 Q Okay. Do you recall if you did?
- 12 A I don't recall.
- 13 Q You don't recall one way or the other, is that right?
- 14 A No.
- 15 Q Okay. What I said is correct, you don't recall one way
- 16 or the other?
- 17 A Correct.
- 18 Q All right. And you don't recall whether Mr. Howey may
- 19 have provided that information, correct?
- 20 A I don't recall whether he provided the information.
- 21 Q Okay. And then the '98 indicates that at least as of
- 22 the time this entry was made, apparently -- well, let me ask
- 23 you what does the 98/ mean, the 98 in reference to the
- 24 people on the right? What is your understanding --
- 25 A Ninety-eight means -- it's normally when the -- the

- 1 assigned officer leaves the scene.
- 2 Q And so in this case --
- 3 A And gives --
- $4 \mid Q$ -- we don't -- excuse me.
- 5 A Leaves the scene and provides a disposition to the
- 6 initial call.
- 7 Q Okay. And in this case we don't know -- it would -- in
- 8 this instance, it would appear that none of the people in
- 9 the right-hand column who were assigned to the scene had
- 10 left at the time this entry was made, correct? Is that how
- 11 one would interpret that, if you know?
- 12 A I can tell you that Deputy Hoops, Gilmore --
- 13 Q I think that's Dana if you have trouble reading it.
- 14 A -- were all there long -- were much longer after
- 15 their -- their shifts ended.
- 16 Q When did your shift end that day?
- 17 A 3:00 o'clock.
- 18 Q Normally it would end at 3:00 o'clock?
- 19 A Yes. Normally it would have ended at 3:00 o'clock.
- 20 Q All right. Now, after Sergeant Gilmore directed you to
- 21 secure the scene --
- 22 A Yes.
- 23 Q -- is that what you did the remainder of the day until
- 24 you left?
- 25 A Yeah. Yes.

- 1 Q Okay. Now, this is June the 5th, a Sunday. Just to be
- 2 complete about this, did you have any further role in the
- 3 investigation of the Ryan/Hughes crimes after June the 5th,
- 4 sir?
- 5 A The investigation of it?
- 6 Q Yes.
- 7 A No.
- 8 Q Okay. Was your role limited to securing the crime
- 9 scene for some period of time?
- 10 A Yes.
- 11 Q And did -- and I didn't ask you this before. When you
- 12 say securing the crime scene, where did you position
- 13 yourself?
- 14 A In the driveway to let certain people in and not permit
- 15 certain people in.
- 16 Q Okay. And I take it public and press was not allowed
- 17 in, is that correct?
- 18 A Correct.
- 19 Q All right. Now --
- 20 A Sheriff's personnel only.
- 21 Q Sheriff's personnel only?
- 22 A Yes.
- 23 Q All right.
- 24 A As well as -- sheriff's personnel only, yes.
- 25 Q And the paramedics were --

- 1 A Paramedics, yes, emergency personnel.
- 2 Q Okay. Thank you. Now, and finally, did a Mr. Lease
- 3 approach you -- did a Mr. Lease talk to you while you were
- 4 in the secure area?
- 5 A Yes.
- 6 Q Securing the area?
- 7 A Yes, Larry Lease.
- 8 Q Larry Lease, and you knew him before?
- 9 A Yes.
- 10 Q And did he ask you to have the house that he
- 11 purportedly owned checked on Sunday, the 5th?
- 12 A I don't recall.
- 13 Q Mr. --
- 14 A I do remember talking to him that day, yes.
- 15 Q Okay. And, Mr. Beltz, you've testified on three prior
- 16 occasions in connection with the Cooper matter, correct?
- 17 A I don't remember how many times --
- 18 Q Well, you've --
- 19 A -- I've testified.
- 20 Q -- testified -- you -- you testified at the preliminary
- 21 hearing. Do you recall that?
- 22 A Yes.
- 23 Q Okay. And then you also testified at trial in November
- 24 of 1984. Do you recall that?
- 25 A Yes.

- MR. ALEXANDER: All right. Well, your Honor,
 maybe -- I don't want to unnecessarily take the time -- if I
 can find the citation in the prior testimony to the
 conversation with Mr. Lease, if I would have permission just
 to bring that to --
- MS. WILKENS: Your Honor, I want to object under 403 because we're not really here about conversations with 8 Mr. Lease.

- 3 something you heard over the radio that day?
- 4 A It -- yes. It would be very normal because normally
- 5 the dispatcher -- if I can relate this to you -- normally
- 6 the dispatcher asks that when there is a call, that would be
- 7 one of the first things, is there any suspect information,
- 8 and that would be one of the primary things that when you
- 9 hear that -- you know, people possibly laying dead some
- 10 place, the dispatcher asks the caller is there any suspect

- MR. ALEXANDER: Thank you, your Honor.
- DIRECT EXAMINATION
- 5 BY MR. ALEXANDER:
- 6 Q Mr. Ward, my name is David Alexander, and I represent
- 7 Kevin Cooper in this matter.
- 8 A Okay.
- 9 Q Have you been subpoenaed to testify?
- 10 A Yes, I have.
- 11 Q And when did you receive the subpoena?
- 12 A I believe last Thursday.
- 13 Q Last Thursday, okay. And was that at your work or at
- 14 your home?
- 15 A That was at my home.
- 16 Q All right. And just the city where your home is.
- 17 Don't tell me your address.
- 18 A Squaw Valley, California.
- 19 Q Squaw Valley?
- 20 A Yes.
- 21 Q That's a nice home. And was the subpoena given to you
- 22 in person?
- 23 A Yes, it was.
- 24 Q And do you remember the name of the gentleman who gave

- 24 A About three days before, maybe on that Monday of that

- 3 A Yes.

- 5 A Yes.
- 6 Q And did Ms. Shakowsky tape-record that interview?

- 19 Q All right. Now, have you ever been a bartender at the
- 20 Canyon Corral Bar in Chino, California?
- 21 A No.
- 22 Q Do you know a Shirley Killian?
- 23 A No.
- 24 Q Do you know an Ed Lauko (phonetic)?
- 25 A No.

- 1 Q Do you know a Virginia McNeal?
- 2 A No, I do not.
- 3 Q Do you know a Kathleen Royals?
- A No.
- 5|Q Have you ever -- well, did you live in the Chino area
- 6 at any time in your life?
- 7 A Yes.
- 8 Q All right. And what years did you live there?
- 9 A I moved to Chino Hills 1979.
- 10 Q And how long did you stay there?
- 11 A Well, until just recently.
- 12 Q Until you moved to Squaw Valley?
- 13 A Yes.
- 14 Q All right. And have you at any -- were -- let me ask
- 15 you this. Were you a regular at the Canyon Corral Bar? In
- 16 other words, did you go there with a great deal of
- 17 frequency?
- 18 A I had never been there before that night.
- 19 Q Okay. Had you -- have you ever in your life that you
- 20 can recall been referred to as Big Al?
- 21 A Yes.
- 22 Q Okay. And was that a regular -- how tall are you, sir?
- 23 A I was six one. I'm shrinking now. I'm 60 years old.
- 24 Q Okay.
- 25 A I'm not as tall.

- 1 Q And about approximately how much do you weigh?
- 2 A About 175.
- 3 Q Okay. Were you ever a much larger man?
- 4 A Yes.
- 5 Q Now, did I ask you have you ever served as a bartender
- 6 at the Canyon Corral Bar? I think I did.
- 7 A Yes, you did ask me, and no, I have not.
- 8 Q You have not. Now, did you at some point learn about
- 9 the Ryan/Hughes crimes?
- 10 A Yes, I did.
- 11 Q And do you recall how you learned of it?
- 12 A Over the TV.
- 13 Q Over the TV?
- 14 A Yes.
- 15 Q And did you learn about it -- do you remember the day
- 16 you learned about it?
- 17 A I remember the day, yes. It was a weekend I believe --
- 18 Q Okay.
- 19 A -- that we learned about it because we live very close
- 20 to the Chino Prison. We first learned that prisoners had
- 21 escaped.
- 22 Q Okay.
- 23 A And then later we learned that a family was slain.
- 24 Q All right. Now, you -- is it correct, sir, that based
- 25 on what you testified previously, that you were in the

- 1 Canyon Corral Bar the evening, Saturday evening or early
- 2 into a Sunday morning?
- 3 A No, it was not a Saturday.
- 4 Q It was not?
- 5 A It was a Friday night.
- 6 Q It was a Friday night?
- 7 A Yes.
- 8 Q And you're certain of that?
- 9 A I'm certain because I was on my way home from El Toro
- 10 Marine Corps Air Base where I worked as a computer operator.
- 11 Q And was it light out when you were there?
- 12 A No. It was after midnight.
- 13 Q It was after midnight?
- 14 A Yes.
- 15 Q So was it Thursday going into Friday or Friday going
- 16 into Saturday?
- 17 A Friday going into Saturday.
- 18 Q So it was the end of your work week, is that a fair
- 19 statement?
- 20 A Yes, that's right.
- 21 Q All right. And is there a particular reason why you
- 22 have a specific recollection that it was a Friday night
- 23 going into a Saturday?
- 24 A Yes, because I picked up a couple that had a -- their
- 25 car broke down in Carbon Canyon. That was my route home

- 1 from El Toro Marine Corps Air Base.
- 2 Q And where did you pick this couple up at?
- $3 \mid A$ In the canyon right near the park that's there.
- 4 There's a park, a state park in Carbon Canyon. I picked
- 5 them up near there.
- 6 Q I'm going to ask you to do me a favor, sir. There's a
- 7 notebook in front of you --
- 8 A Okay.
- 9 Q -- that has a map --
- 10 MR. ALEXANDER: If I might approach, your Honor?
- THE COURT: You may. You don't have to ask.
- 12 BY MR. ALEXANDER:
- 13 Q I'm going to direct your attention, sir, and since I
- 14 don't have a copy, to what we have previously marked as RRR,
- 15 RRR-1.
- 16 A Okay.
- 17 Q Okay. And I'll represent to you that this is a map of
- 18 the -- portions of the Chino and Chino Hills area.
- 19 A Right, right.
- 20 Q Now, can you describe since pointing doesn't help us
- 21 with the record --
- 22 A Right.
- 23 Q -- where the park is that you picked up these two
- 24 people?
- 25 A Chino Hill Parkway is now the road that used to be --

- 1 Q Carbon Canyon?
- A -- Carbon Canyon, yes, but now it's Chino Hill Parkway,
- 3 and that is the road that I picked the people up on just as
- 4 you come into the canyon off of Valencia Avenue.
- 5 Q Okay.
- 6 A And that's here in this area here.
- 7 Q Over here.
- 8 A They don't really have that on the map here.
- 9 Q It would be at the top of the map?
- 10 A Right.
- 11 Q So that's off the map?
- 12 A Right.
- 13 Q Approximately how far from the Canyon Corral Bar did

- 20 you?
- 21 A Well, they invited me in there because they wanted to
- 22 buy me a beer for giving them a lift through the canyon. It
- 23 was very dark and unlit at that time.
- 24 Q Okay. Was the Canyon Corral Bar very crowded when you
- 25 got into it after midnight?

- 1 A Yes, I would -- I would say so for a Friday night.
- 2 Q And was -- was there music playing, do you recall?
- 3 A Yes, yes.
- 4 Q A band?
- 5 A No. They had a jukebox.
- 6 Q A jukebox, okay. And is there -- let's see, this is
- 7 1983. When did you say you first lived in Chino?
- 8 A '79.
- 9 Q '79, so --
- 10 A I moved there.
- 11 Q -- is there a reason why you had never been into the
- 12 Canyon Corral Bar before you were invited by these people?
- 13 A I'm married, two kids, a wife. I was on my way home.
- 14 I didn't frequent bars.
- 15 Q Okay.
- 16 A The only clubs I went to were on El Toro, and that was
- 17 the Officers' Club where we had parties or we ate because I
- 18 was of the rank -- well, not the rank but I was of the GS
- 19 status where I could go into the Officers' Club.
- 20 Q All right. How long did you stay in the bar that
- 21 evening?
- 22 A About 20 minutes.
- 23 Q All right.
- 24 A Fifteen or 20 minutes.
- 25|Q All right. And you got -- got your beer?

- l A I drank one beer, and I left.
- 2 Q All right. Now, that evening did you -- after 12:00
- 3 o'clock -- well, first of all, where did you sit in the bar?
- 4 A We sat at a table.
- 5|Q At a table?
- 6 A Yes, they had --
- 7|Q Was it a booth or a table?
- 8 A A table. I don't think they had booths.
- 9 Q All right. You don't recall any booths?
- 10 A No, I don't recall a booth.
- 11 Q All right. And did you observe at some point while you
- 12 were there any persons coming into the bar that attracted
- 13 your attention?
- 14 A Yes. As we were going into the bar, three young men
- 15 were coming from around -- looks like they came from around
- 16 on the side. This was an older western style bar that had a
- 17 porch that went around it to the sides on both sides. On
- 18 the right side, which was Payton Drive -- Eucalyptus Avenue
- 19 and Payton Drive -- well, Payton Drive it was, there was
- 20 three men coming from around the back with extremely bloody
- 21 T-shirts on, white T-shirts, unmarked T-shirts.
- 22 Q You saw them outside the bar?
- 23 A They were outside, but they did come inside the bar.
- 24 Q All right. And you saw them inside the bar?
- 25 A Yes, they did come in.

- 1 Q And did they stay in the bar very long?
- $2\mid A$ They disappeared in the bar. I think -- I'm assuming
- 3 they went into the rest room. They were sort of jousting
- 4 around.
- 5 Q I don't want you to assume. Tell me what you observed,
- 6 please.
- 7 A Well, I -- I saw them disappear from out of the bar
- 8 area where we were sitting, but we looked around and
- 9 there they came in, and I just thought they were extremely
- 10 bloody.
- 11 Q Uh-huh. And can you describe the men -- these men any
- 12 more? Were they young males?
- 13 A They were young white males.
- 14 0 Uh-huh.
- 15 A That's what I appeared -- maybe one could have been
- 16 Hispanic. I don't know, because we didn't -- I become a
- 17 little bit unnerved when I see people bloody like that. I
- 18 thought they had been in a fight, and I didn't want to stay
- 19 in the bar much longer than that.
- 20 Q Did they appear to be drunk or -- or --
- 21 A That's what I thought, but I'm not sure if they were
- 22 drunk or not because I didn't know if they had been in the
- 23 bar previously and gone out and had a little fight and then
- 24 were coming back in the bar. I just noticed that they were
- 25 extremely bloody and nobody seemed to be cut or hurt. So I

- 1 was just a little bit unnerved by that.
- 2 Q What was their hair like of any of them, if you recall?
- 3 A Two were blond I believe, and one had darker hair.
- 4 Q Okay. Was the blond hair long or short?
- 5 A One had longer blond hair. It looked like it might
- 6 have been back in his T-shirt or something, and the other
- 7 one had shorter hair but not very short, maybe --
- 8 Q The one with the dark hair had --
- 9 A One with the darker hair had shorter hair.
- 10 Q Uh-huh.
- 11 A But when I say short, in those days, no one really had
- 12 short hair. So it might have been shoulder length.
- 13 Q Of the person with the dark hair?
- 14 A The dark hair, yes.
- 15 Q Okay.
- 16 A And not very dark hair. I'm saying maybe -- I don't
- 17 know what the hair color was but maybe sandy brown.
- 18 Q Okay. Now, the next day -- you said it was on a
- 19 weekend -- you learned about the Ryan/Hughes crimes,
- 20 correct?
- MS. WILKENS: Objection. Leading.
- 22 THE WITNESS: I'm not sure if it was the next day.
- 23 BY MR. ALEXANDER:
- 24 Q I see. Fair enough. All right. You learned about it
- 25 on a weekend?

- 1 A Yes.
- 2 Q All right.
- 3 A I believe so.
- 4 Q Was the time that you were in the bar or how close in
- 5 proximity to the -- the time you were in the bar Friday
- 6 night going into Saturday, okay, was it to your hearing on
- 7 television about the crimes?
- 8 A I'd say about 24 hours.
- 9 Q Okay.
- 10 A At least.
- 11 Q All right. Now, when you heard about the crimes on the
- 12 television, did your experience in the bar come to mind?
- 13 A Yes.
- 14 Q All right.
- 15 A Right away.
- 16 Q And did you -- did you discuss that with your wife?
- 17 You're not obligated to -- to discuss your conversations
- 18 with -- with your wife, but --
- 19 A My wife was the one who first called my attention to
- 20 it. She said, "Al, look at this. Something on TV about a
- 21 family right near here being slain."
- 22 Q And did you --
- 23 A Then we heard about -- then we -- she said, "And you
- 24 know there was a prison breakout too, " and I said "I know,"
- 25 and I called the police right away.

- 1 Q You did call the police?
- 2 A Yes, I did.
- 3 Q You called the sheriff or the police?
- 4 A I called the sheriff's substation in Ontario at that
- 5 time.
- 6 Q And why did you call there?
- 7 A Because I wanted to let them know I had seen those
- 8 three men who were bloody.
- 9 Q Okay. But why did you call that substation as
- 10 opposed --
- 11 A That was --
- 12 Q Excuse me. Let me just finish my question. I'm sorry.
- 13 A Okay.
- 14 Q I'm probably talking over you, and that's causing you
- 15 to talk over me, and I apologize. Why did you call the
- 16 Ontario Substation as opposed to the Chino Station?
- 17 A We didn't have a substation down there at that time.
- 18 There was no Chino Substation on Grand where it is now.
- 19 Q I see. Was -- are you familiar with the West End
- 20 Station?
- 21 A Yes.
- 22 Q Okay. Is that -- and that existed at that time,
- 23 correct?
- 24 A The station that I was familiar with at that time was
- 25 on Sixth Street and Mountain Avenue.

- 1 Q And is that --
- 2 A In Ontario.
- 3 Q Is that the -- in Ontario?
- 4 A Yes.
- 5 Q That's the one you were most familiar with?
- 6 A That was the only one we had at that time.
- 7 Q Okay. Best of your recollection?
- 8 A Best of my recollection.
- 9 Q And what did -- do you recall who you spoke to at the
- 10 Ontario Station?
- 11 A No, I do not.
- 12 Q Did you make any notes of what you did on --
- 13 A No.
- 14 Q -- the day that you learned of the crimes?
- 15 A No, I didn't make any notes.
- 16 Q Okay. Did you discuss your experience at the Canyon
- 17 Corral Bar with your wife?
- 18 A Not that night, not until after we found out about the
- 19 Ryan and Hughes families.
- 20 Q Please excuse the nature of this question, but is your
- 21 wife still alive?
- 22 A Yes.
- 23 Q And you're still happily married?
- 24 A No, we're divorced, but we're still friends.
- 25 Q You're on speaking turns?

- 1 A Very -- yes, we have two sons.
- 2 Q Very well. All right. And does she -- what is her
- 3 first name?
- 4 A Alma.
- 5 O Alma?
- 6 A Yes, Alma Ward.
- 7 Q A-L --
- 8 A A-L-M-A.
- 9 Q All right. And just tell me the city she lives in, and
- 10 I don't want to know her address.
- 11 A Chino Hills.
- 12 Q She lives in Chino Hills still?
- 13 A Yes, still. My family all lives in Chino Hills still
- 14 today.
- 15 Q How old were your boys at the time?
- 16 A Seven and two.
- 17 Q Okay. So now we're 21 years later.
- 18 A Yes.
- 19 Q And they're 23 and 28 respectively?
- 20 A Yes, just turned 28 August 21st my oldest, and my
- 21 youngest is 23 and a half.
- 22 Q And do they live in the area?
- 23 A They live in Chino Hills.
- 24 Q All right. Do they live with their mother or with you?
- 25 A No. They live in a condo owned by their mother, and

- 1 their mother lives in a house in Chino Hills.
- 2 Q Okay. And what are their names?
- 3 A Alfred Junior and Allen.
- 4 Q I'm sorry, Alex?
- 5 A Allen.
- 6 Q Allen.
- 7 A A-L-L-E-N.
- 8 Q Now, were you -- after your call to the Ontario
- 9 Police -- I'm sorry -- Ontario Sheriff's Station, were you
- 10 ever contacted by any Sheriff's -- any person who you
- 11 understood to be affiliated with law enforcement?
- 12 A No.
- 13 Q Did you yourself do anything further?
- 14 A I called again.
- 15 Q You did?
- 16 A After they caught Kevin Cooper, I called again.
- 17 Q And if I represent to you that Kevin Cooper was caught
- 18 on or about July 30th or 31st of 1983, how soon after did
- 19 you call again?
- 20 A The day I heard it on TV that they caught the person
- 21 that broke out and may be responsible for this, I called
- 22 them and told them I had seen -- I saw the other three men.
- 23 Q And do you -- do you recall who you spoke -- withdraw
- 24 that. Did you call the Ontario Station again?
- 25 A Yes, I did.

- 1 Q All right. And do you recall who you spoke to at the
- 2 Ontario Station?
- 3 A I think I spoke to the watch commander.
- 4 Q Okay. Do you recall that person's name?
- 5 A No, I do not.
- 6 Q After that, were you ever -- were you ever contacted by
- 7 sheriffs, anybody who you understood to be affiliated with
- 8 law enforcement?
- 9 A No, I was not.
- 10 MR. ALEXANDER: Okay. Just one moment, your
- 11 Honor. No further questions. Thank you very much, Mr.
- 12 Ward.
- 13 THE WITNESS: You're welcome.
- MR. ALEXANDER: Thank you for coming down from
- 15 Squaw Valley. I think maybe if we'd taken a vote, we might
- 16 have voted to go up there. Thanks again.
- 17 THE WITNESS: You're welcome.
- 18 CROSS EXAMINATION
- 19 BY MS. WILKENS:
- 20 Q Now, Mr. Ward, you indicated that you picked up a
- 21 couple at the park. Their car was broken down?
- 22 A Yes.
- 23 Q And they were seated with you at the bar while you had
- 24 your beer?
- 25 A Yes.

- 1 Q And had you ever seen them before?
- 2 A Never saw them before.
- 3 Q Have you ever seen them since?
- 4 A No.
- 5 Q Do you recall their names?
- 6 A No. I -- I didn't even ask their names.
- 7 Q Can you describe them?
- 8 A I believe it was two ladies or it may have been a man
- 9 and a woman, but I just -- my recollection is it was two
- 10 ladies.
- 11 Q And you indicated that you were -- you were concerned
- 12 about the appearance of these men because of the blood,
- 13 correct?
- 14 A Yes.
- 15 Q Did you discuss that with the two persons that were
- 16 with you that night?
- 17 A No, we did not.
- 18 Q And when you returned home that night after -- after
- 19 having a beer at the bar, did -- did you tell anyone about
- 20 what you saw?
- 21 A No, I didn't. I -- usually at that time everyone's
- 22 asleep in my house. The kids were asleep. My ex-wife was
- 23 asleep. I usually watch TV or the news or something, and
- 24 then I'd go to bed.
- 25 Q All right. So did you -- did you call the Sheriff's

- 1 Department that night?
- 2 A No.
- 3 Q All right.
- 4 A Not that night.
- 5 Q Now, you indicate that you called the Sheriff's
- 6 Department after you learned of the homicides?
- 7 A Yes.
- 8 Q And counsel's referring to it as the Ontario Sheriff's
- 9 Station, but is it correct that when you lived in Chino
- 10 Hills in 1983 that your sheriff's substation for Chino Hills
- 11 was located at Sixth and Mountain?
- 12 A Yes.
- 13 Q And that was in Ontario?
- 14 A That's right.
- 15 Q So you called your local sheriff's substation?
- 16 A Yes.
- 17 Q All right.
- 18 A That's where you had to call if you needed a police
- 19 officer. They'd have to come from Ontario. They had
- 20 regular officers in that area on patrol, but they didn't
- 21 have a substation at that time.
- 22 Q Now, when you called the local substation, did you ask
- 23 to speak to anyone in particular or did you just speak to
- 24 who answered the phone?
- 25 A I just spoke to who answered the phone.

- 1 Q And what did you tell them?
- A I told them what I'd seen at the bar, at the Canyon
- 3 Corral and could it -- asked them if it could possibly some
- 4 of the men who came -- broke out of prison, and they said
- 5 they'd investigate that I believe is what they told me, they
- 6 would investigate, which I thought they meant they'd come to
- 7 my house and ask me questions about it.
- 8 Q Right. So you gave your name?
- 9|A Yes.
- 10 Q You gave your phone number?
- 11 A Yes.
- 12 Q You gave your address?
- 13 A Yes.
- 14 Q And in 1983, where did you reside in Chino Hills?
- 15 A I resided at 14554 Sandbar Street, and that's at the
- 16 corner of Irvine Drive and Eucalyptus Avenue which was just
- 17 right off of Payton Drive.
- 18 Q And when you made this phone call, do you -- do you
- 19 recall how long after you learned of the murders that you
- 20 made this phone call?
- 21 A It had to be at least two days before we learned
- 22 anything about the murders.
- 23 Q And how long after learning of the murders did you wait
- 24 to call the sheriff's substation?
- 25 A I called the same day that I learned about them because

- I just put the bloody T-shirts together with they said four people had broken out of Chino Prison, not one, four, and they gave the names, not Kevin Cooper's name. They gave another name, a Jewish name of a young man, and when they said they caught Kevin Cooper, a black man, we said -- I said, well, I saw these other three guys bloody. I don't know who Kevin Cooper is because they didn't come up with his name. They had another name. I forget exactly what it was, but it was a name that would be attributed usually a
- 11 Q Now, you spoke to your wife about what you saw at the
- 12 bar after you learned of the murders?
- 13 A Right.
- 14 Q Did you speak to anybody else besides your wife about 15 what you observed?
- 16 A No, I did not.
- 17 Q And what did you tell your wife you observed?

10 Jewish name, and I knew that wasn't Kevin Cooper.

- 18 A I told her that I had picked up a couple in the canyon
- 19 and we went into the bar for a beer and that three guys
- 20 bloody came in there. They had bloody T-shirts on I believe
- 21 and khaki type pants, and that's what I noticed.
- 22 Q Now, you didn't tell your ex-wife that you saw three
- 23 men in a field in broad daylight with blood on them with
- 24 helicopters flying overhead?
- 25 A No.

- LQ That's not what you told her?
- 2 A No. Never saw them in daylight.
- Q Okay. And you've never -- you were never in the Canyon
- 4 Corral Bar prior to that evening, is that correct?
- 5 A Never before. I knew the owners were Iranian guys that
- 6 I knew because they had another liquor store down in the
- 7 canyon that only sold the kind of beer that I drank. It was
- 8 Genesis Cream Ale from Connecticut, and they were the only
- 9 ones that sold it, and I went in there. The night I went in
- 10 the bar, one of the men recognized me and says, "Oh, you
- 11 finally come to our bar. " And I said, "Yes, I -- I'm being
- 12 treated to a beer by these ladies." I believe it was two
- 13 young ladies, and -- and he remembered me because I'd bought
- 14 the cream ale, and they owned both the canyon bar and they
- 15 owned the liquor store down in Sleepy Hollow, which is the
- 16 city in canyon -- Carbon Canyon called Sleepy Hollow.
- 17 Q So the man who recognized you inside the Canyon Corral
- 18 Bar that night, did you recognize him to be the gentleman
- 19 that would sell you liquor at the liquor store?
- 20 A Yeah, he -- he worked at the bar sometimes, and then
- 21 that liquor store would close, and they'd work at the bar.
- 22 Q All right. Now, was he an employee of the bar or the
- 23 owner?
- 24 A He was the owner.
- 25 Q The owner of the bar?

- 1 A Not an employee. It's Iranian brothers I believe owned
- 2 it, very nice guys.
- 3 Q Do you remember his name?
- 4 A No, I do not.
- 5 Q Did anyone else inside the bar recognize you that night
- 6 to your knowledge?
- 7 A No. I didn't know anyone in that area.
- 8 Q All right. And you didn't recognize anyone?
- 9 A No.
- 10 Q Now, you mentioned that the bar was crowded for a
- 11 Friday night?
- 12 A Yes.
- 13 Q Now, how would you know what was --
- 14 A Well, because I passed by there all the time, and the
- 15 number of cars parked there would let you know that it's
- 16 more people there than normal. Usually it's three or four
- 17 cars. It was maybe eight to 10 cars because I tried to
- 18 park -- I was in an Austin Healy MK3000 convertible, which
- 19 is a very recognizable car because it's pretty old. It was
- 20 a '63, and these ladies barely could fit in there. It's one
- 21 seat beside me, and then there's a little seat like you have
- 22 in a Porsche in the back, and then that's where the other
- 23 person was stretched across. So when I parked, I had to
- 24 squeeze on the grass almost to park there, and I didn't
- 25 really want to go in, but they insisted that they buy me a

- 1 beer, so I went in and had a beer with them.
- Q All right. So your normal route home from work would
- 3 take you past the Canyon Corral Bar on Friday nights?
- 4 A Every night of the week, yes, and even on the weekends
- 5 because I had a friend who lived in Brea, and that was the
- 6 way I'd go to his house. He lived right off of Lambert. So
- 7 I'd go that way.
- 8 Q All right. Now, you were inside the bar for
- 9 approximately 15 to 20 minutes, correct?
- 10 A That's all.
- 11 Q All right. And when you left the bar, were the men
- 12 still inside?
- 13 THE COURT: Could I get the time?
- 14 MS. WILKENS: Pardon?
- THE COURT: Could I get the time?
- 16 MS. WILKENS: Yes.
- THE WITNESS: I -- I got off -- I worked 3:00 to
- 18 11:30 at El Toro Marine Corps Air Base. So it took me about
- 19 45 minutes to get from El Toro up to -- I'd come up the 5 to
- 20 the 57, and I'd get off the 57 at Lambert Road, and I'd come
- 21 to Carbon Canyon. It took me about 45 minutes. It was
- 22 about 12:15 or a little bit later when I picked --
- 23 BY MS. WILKENS:
- 24 Q All right. So normally when you would drive home, you
- 25 would get off work at 11:30?

- L A Yes.
- 2 Q And you would arrive home at approximately 12:15?
- 3 A Basically, yes.
- 4 Q So pretty much a 45-minute drive?
- 5 A Yes.
- 6 Q But on this evening you stopped at the park to render
- 7 assistance?
- 8 A Right.
- 9 Q Okay. So your estimate would be that you arrived at
- 10 the Canyon Corral Bar at approximately 12:15?
- 11 A 12:15, 12:20, in that area.
- 12 Q All right. And then you remained for approximately 15
- 13 to 20 minutes?
- 14 A Yes.
- 15 Q So you would have been leaving sometime between 12:35
- 16 and 12:40 in the morning?
- 17 A Right.
- 18 Q Do you recall what time you got home that night?
- 19 A No, I do not, but I -- my wife always expected me home.
- 20 I came home at the same time every night. I never stopped
- 21 anywhere. So she would -- if I didn't get home by 1:00
- 22 o'clock, she would be worried. There were no cell phones at
- 23 that time, and I -- I would go straight home. That's why I
- 24 didn't want to stay in the bar much longer than I did
- 25 because she would normally wake up thinking "Well, Al's not

- 1 here yet."
- 2 Q All right. When you arrived home, was your wife awake
- 3 and worried?
- 4 A No, she was not.
- 5 Q Okay. Now, with respect to the three young men, you've
- 6 indicated that all three were wearing white T-shirts,
- 7 correct?
- 8 A Yes.
- 9 Q And did you see any writing on the T-shirts?
- 10 A No. There was no writing. If it was, it was covered
- 11 in blood, and I didn't see any writing. There was no
- 12 writing.
- 13 Q All right. Now, when you describe covered in blood,
- 14 did all three men have the same quantity of blood?
- 15 A No, I can't say they did.
- 16 0 Where was the blood located?
- 17 A All over the front of their shirts.
- 18 Q All right. So all three men had blood on the front of
- 19 their shirts?
- 20 A And arms.
- 21 Q And the arms of the shirts?
- 22 A Yes -- no, the arms -- their arms.
- 23 Q Their arms?
- 24 A Their skin.
- 25 Q And you saw them outside the bar at approximately 12:15

- 1 in the morning?
- 2 A As we pulled up.
- Q All right. And you were pulling up out front, and they
- 4 were walking around the side?
- 5 A They were coming on the right side, like they were
- 6 coming up Payton Drive.
- 7 Q All right. Did they walk --
- 8 A From the vicinity --
- 9 Q Did they walk past you?
- 10 A They walked into the bar. We went in first. They were
- 11 outside jousting around like they had been playing around or
- 12 punching each other or something.
- 13 Q All right. When they were outside jostling, before you
- 14 walked in the bar, approximately how far away were they from
- 15 you at that time?
- 16 A Ten feet.
- 17 Q Okay. About 10 feet away. At that time, did you
- 18 notice the blood on their clothing?
- 19 A Yes.
- 20 Q And did you discern it to be blood?
- 21 A Oh, yes.
- 22 Q All right. So there was no doubt in your mind that it
- 23 was blood?
- 24 A None whatsoever.
- 25 Q All right. Was it specs?

- A No. It was not specs.
- 2 Q Okay. Can you describe for me the quantity of blood on
- 3 the front of their shirt?
- 4 MR. ALEXANDER: Objection. Vague.
- 5 THE COURT: Overruled.
- 6 THE WITNESS: I'm thinking if someone had a cup of
- 7 blood and threw it on someone's shirt, the front areas were
- 8 bloodier than the sides. Maybe there was some spattered
- 9 looking blood on their arms and all, but most of the shirt
- 10 was -- both -- all three of thems' shirts were saturated I
- 11 would say, almost saturated.
- 12 BY MS. WILKENS:
- 13 Q All right. So the front of the shirts were saturated
- 14 with blood?
- 15 A I would think so.
- 16 Q All right. And on their arms, you would describe it as
- 17 specs?
- 18 A Yes, spattered.
- 19 Q Spattered?
- 20 A Or -- or smeared more.
- 21 Q Smears?
- 22 A Yes.
- 23 Q Okay.
- 24 A Like -- like they'd been in a tussle or something.
- 25 Q All right. But you indicated that you saw no signs of

- 1 injury on them?
- 2 A No, no nose bleeding, no cuts.
- B|Q All right. You didn't see any blood on their faces?
- 4 A No.
- 5 Q Did you see any blood on their pants?
- 6 A Yes, blood ran -- well, see, the shirts were long.
- 7 Q All right. Were they tucked in?
- 8 A No, they were not tucked in.
- 9 Q Okay. So all three men were wearing white T-shirts
- 10 that were not tucked in?
- 11 A Yeah. In -- in those days that was attire for -- a lot
- 12 of Mexican-Americans wore white T-shirts and khaki pants in
- 13 those days. It was sort of like an attire.
- 14 Q All right. Do you recall the pants that they were
- 15 wearing?
- 16 A They were light tan I believe, khaki type pants.
- 17 Q All three had khaki --
- 18 A Dressed alike, yes.
- 19 Q They were dressed alike. Do you recall their shoes?
- 20 A My recollection is that the shoes were white, like
- 21 bedroom slippers.
- 22 Q Okay.
- 23 A That's what I thought.
- 24 Q And all three had the same shoes?
- 25 A I didn't pay attention to the shoes as much because the

- 1 pants were long and rolled up a little, like they had rolled
- 2 them up at the bottom, like --
- 3 Q All right. So --
- 4 A -- they were too big for them.
- 5 Q -- they were -- they weren't cuffed. They were rolled
- 6 up?
- 7 A No, they weren't cuffed.
- 8 Q All right. And all three had the similar rolling of
- 9 the pants?
- 10 A Yes.
- 11 Q Okay. And then with respect to the blood on their
- 12 pants, did they all have an equal quantity of blood on their
- 13 pants?
- 14 A I can't say that they had an equal quantity, no.
- 15 Q All right. Did it look like smears of blood?
- 16 A It looked like smears, yes.
- 17 Q All right. And when the men came into the bar, were
- 18 you already seated in the booth?
- 19 A We weren't in a booth. We were seated at a table I
- 20 believe.
- 21 Q All right.
- 22 A Near a window. I do remember it was near a window.
- 23 Q All right. And so you were already seated when they
- 24 came into the bar?
- 25 A Yes.

- 1 Q Did you observe them inside the bar?
- 2 A Yes, of course.
- Q Okay. How close did they come to you where you were seated in the bar?
- 5 A They went near the bar where you sit at the bar. They
- 6 went near the bar which I think there was a rest room. I
- 7 had never been in before, but they went toward the back
- 8 where I think they disappeared into the rest room.
- 9|Q All right.
- 10 A Because they weren't sitting at a table, and they
- 11 didn't sit at the bar.
- 12 Q Did you see them again after --
- 13 A No. I left before they reappeared.
- 14 Q All right. So could they have gone outside?
- 15 A No, they weren't outside because I would have seen them
- 16 while I was leaving. I left, and they were still inside the
- 17 bar, and my estimation is that they went into the rest room
- 18 to clean themselves up.
- 19 MR. ALEXANDER: Objection. Move to strike.
- 20 Speculation.
- THE COURT: Overruled -- well, as far as
- 22 speculation, sustained. I have just some people to meet
- 23 with. So I'll take our morning recess now, and we'll be in
- 24 recess for 15 minutes, and then we'll resume.
- 25 (Proceedings recessed briefly.)

- THE COURT: We're back in session. We remind you you're still under oath.
- MS. WILKENS: Thank you, your Honor.
- 4 BY MS. WILKENS:
- 5 Q Now, Mr. Ward, the three men that you saw inside the
- 6 Canyon Corral Bar, could you indicate to me -- I believe you
- 7 indicated there were two blond and one with darker hair?
- 8 A Yes.
- 9 Q The two blonds, could you please indicate the length of
- 10 their hair?
- 11 A One I can't remember because it was pushed to the back
- 12 and I think maybe down in his T-shirt. I can't be sure
- 13 about that. The other one had I would say close to
- 14 shoulder-length hair.
- 15 Q Now, the gentleman who had his hair pulled back, was it
- 16 in a ponytail?
- 17 A Maybe.
- 18 Q All right. So you just couldn't really see where it
- 19 went?
- 20 A No, I couldn't see where it went, how far down.
- 21 Q Okay. And the gentleman with darker hair, would you
- 22 say it was brown?
- 23 A Yes.
- 24 Q Okay. So it wasn't black?
- 25 A No.

- 1 Q Okay.
- 2 A I'm not sure if it was black.
- 3 Q And what was the length of the man's hair that was
- 4 brown hair?
- 5 A I would say shorter than shoulder length, just more of
- 6 a curlier type hair. That's what I remember.
- 7 Q Now, could you indicate the height of the man with the
- 8 brown hair?
- 9 A None of them were as tall as I was. I would think they
- 10 were all between five seven and five nine.
- 11 Q Okay. And your height at the time was six one?
- 12 A I was about six one, yes.
- 13 Q Okay. And approximately how much did you weigh at that
- 14 time?
- 15 A About 200 pounds.
- 16 Q And was there anything about these men that would have
- 17 attracted your attention but for the blood on their clothing
- 18 and on their arms?
- 19 A No, not really. The fact that they were dressed alike
- 20 didn't really -- if they weren't bloody, I wouldn't have
- 21 noticed that so much because a lot of guys did dress alike
- 22 that were buddies in those days.
- 23 Q Now, you mentioned that the -- the Iranian gentleman
- 24 who owned both the bar and the liquor store who recognized
- 25 you that night spoke to you, is that correct?

- 1 A Yes.
- 2 Q And you didn't speak to him about the three men's
- 3 appearance?
- 4 A No.
- 5 Q And you didn't call it to the attention of anyone else
- 6 in the bar?
- 7 A No. I didn't know anyone in there, and I assumed
- 8 that -- I just thought that everyone did see them. They
- 9 were loud.
- 10 Q Okay. Now, after Mr. Cooper had been captured, you
- 11 indicated that you telephoned once again the sheriff's
- 12 substation, correct?
- 13 A Yes.
- 14 Q And you were under the impression you spoke to the
- 15 watch commander?
- 16 A I believe so.
- 17 Q Okay. And why do you believe you spoke to the watch
- 18 commander?
- 19 A Because that's what they -- he said he was, the watch
- 20 commander.
- 21|Q All right. Did he -- did you ask to speak to someone?
- 22 A No. It was the person who answered the phone, and I
- 23 said -- I told him my name, and he said officer so and so,
- 24 the watch commander. That's what I remember him saying.
- 25 Q Okay. And you don't remember his name?

- 1 A No, I don't.
- 2 Q Did you provide him with your name and phone number?
- 3 A Yes.
- 4 Q And your address?
- 5 A Yes.
- 6 Q Did you reference the fact that you had called earlier?
- 7 A Yes.
- 8 Q Okay. Now, prior to testifying here today, did you
- 9 ever talk to any representative for Mr. Cooper?
- 10 A Never.
- 11 Q All right. So you never spoke to Mr. Cooper's defense
- 12 attorney?
- 13 A Today -- yesterday.
- 14 Q Okay.
- 15 A Last night.
- 16 Q All right. Last night. Who did you speak to last
- 17 night?
- 18 A Attorney Ali.
- 19 Q Okay. So that would be Mr. Kazemi?
- 20 A Yes, Mr. Kazemi.
- 21 Q Okay. And you spoke to Mr. Kazemi by phone?
- 22 A No. We met in person in my hotel room.
- 23 Q All right. So he came by and spoke to you in your
- 24 hotel room, and what did you talk about?
- 25 A The case, what I saw, exactly what I'm telling you. We

- 1 talked about the men with the bloody T-shirts and the
- 2 approximate time I came home from work that night and two
- 3 ladies or the lady and the man. I can't be certain about
- 4 whether it was two ladies, but I'm -- I mean, my
- 5 recollection is it was two young ladies.
- 6 Q All right. And other than your call to the sheriff's
- 7 substation after you learned of the murders and your call to
- 8 the watch commander after Mr. Cooper was apprehended and
- 9 your discussion with your ex-wife, have you spoken to
- 10 anybody -- before speaking to the Attorney General's Office
- 11 or Mr. Cooper's counsel yesterday, have you spoken to
- 12 anybody about what you saw that night?
- 13 A Yes, friends.
- 14 Q Okay. And did you speak to them close in time to when
- 15 you made the observations?
- 16 A No, no. I just spoke to them here recently.
- 17 Q Recently. Okay.
- 18 A When the case --
- 19 Q And who did you speak to?
- 20 A I spoke to a friend of mine, Mr. Jay Carlisle because I
- 21 told him I was trying to get in touch with -- I told him
- 22 many years ago I had witnessed three men, and he didn't know
- 23 anything about the case. I told him and maybe I told -- I
- 24 told my attorney. I have an attorney, a Workman's Comp
- 25 attorney. I told him about it, but I just left a message on

- 1 his phone about it.
- Q Okay. And that would be recently?
- 3 A Yes, recently.
- 4 Q Okay.
- 5 A Just while I was in the airport en route here.
- 6 Q Okay. And with respect to -- to your initial telephone
- 7 call to the sheriff's station, you told them that you saw
- 8 three men?
- 9 A Yes.
- 10 Q And what did you tell them about the men?
- 11 A I just told them I saw three men with bloody T-shirts
- 12 on.
- 13 Q Okay.
- 14 A That's the extent of it.
- 15 Q All right.
- 16 A I told him many years ago there was a murder in our
- 17 neighborhood and I saw three men coming into the bar and
- 18 that I -- I was going to testify or try to tell the court
- 19 what I saw.
- 20 Q Now, this is what you --
- 21 A I told my sons also.
- 22 Q Okay. You -- you told your sons about this?
- 23 A Yes. Oh, yes. I told my sons the -- when the -- when
- 24 the newspaper came out that -- and had the names of the
- 25 attorneys and said if you had any information, give this

- 1 number a call, I called that number, and it was the wrong
- 2 number.
- 3 Q Okay. Now, when -- when did you make a telephone call
- 4 based on reading the newspaper, what year?
- 5 A This year.
- 6 Q All right. So sometime this year --
- 7 A Right after Governor Schwarzenegger decided not to
- 8 execute Kevin Cooper, in the Progress Bulletin or either the
- 9 Press Enterprise -- I'm not sure which paper it was -- comes
- 10 to my son's house, and I read it, and I said I'm going to
- 11 call this number, and I called the number so I could get in
- 12 touch with the attorneys, but it was not the right number.
- 13 Q Okay.
- 14 A So I did call the newspaper then and leave a message
- 15 with the reporter.
- 16 Q All right. And did you try to get the defense
- 17 attorney's phone number?
- 18 A Yes.
- 19 Q And were you successful?
- 20 A Well, no, because the reporter had just an answer
- 21 system there. There was no -- I never spoke to anyone.
- 22 Q All right. So you weren't able to leave a message?
- 23 A No -- I left a message.
- 24 Q Okay. But you didn't get a call back?
- 25 A No, I never got a call back.

- 1 Q Okay. And at that point you told your son about what
- 2 you had seen?
- 3 A Both my sons, yes.
- 4 Q Both your sons. Had you told them that previously?
- 5 A Yes.
- 6 Q Okay. When's the first time you recall telling them?
- 7 A I -- right after -- when -- when it came up that they
- 8 were asking the governor to stop the execution, I told my
- 9 sons, and they remembered because my ex-wife had told them,
- 10 "Your dad knows something about that case, and he
- 11 witnessed, " because my ex-wife -- and then she told me, she
- 12 said I -- she saw it on the news where the governor had
- 13 already stopped -- you know, decided to sign papers to stop
- 14 the execution. So I said, "Well, I need to call up right
- 15 now and let them know that I know something. I want to be a
- 16 witness because I think those guys in the bloody T-shirt may
- 17 have had something to do with this. So I called.
- 18 Q You called the press?
- 19 A I called the press, Enterprise, which they had the
- 20 number for the attorneys there, but it was not the right
- 21 number.
- 22 Q Okay. So they had a number printed in the paper,
- 23 but --
- 24 A Yes.
- 25 Q -- you dialed it, and you didn't get the attorney?

- 1 A It did not go to the attorneys.
- 2 Q Okay. Who is Mr. Carlisle?
- 3 A Mr. Carlisle is a friend of mine.
- 4 Q Okay. And when did you tell Mr. Carlisle?
- 5 A Recently when I was taking him to VA Hospital for
- 6 surgery, maybe about three, four months ago. He had a
- 7 nervous breakdown, and I was taking him into the hospital, a
- 8 veteran friend of mine.
- 9 Q And how did you get on the subject of the Cooper case
- 10 with Mr. Carlisle?
- 11 A It was right after the governor had stopped the
- 12 execution, and I told him I knew something about that case.
- 13 We might have heard something on the news as we were driving
- 14 to the hospital, and I told him I knew something about this
- 15 case and I'm going to try to call and let them know what I
- 16 know.
- 17 Q Okay. So other than your sons and your ex-wife and Mr.
- 18 Carlisle and your Worker's Comp attorney, you've not
- 19 discussed this with anyone?
- 20 A No.
- 21 MS. WILKENS: Okay. Thank you, your Honor. No
- 22 further questions.
- MR. ALEXANDER: Just very briefly.
- 24 //
- 25 //

REDIRECT EXAMINATION

- 2 BY MR. ALEXANDER:
- 3 Q I'd like to ask you some very fundamental questions,
- 4 sir. You -- am I correct that you worked for the federal
- 5 government for approximately 20 -- over 20 years?
- 6 A Yes.
- 7 Q And what was your position?
- 8 A Well, I was a computer specialist at El Toro Marine
- 9 Corps Air Base.
- 10 Q All right.
- 11 A And then after that job, I worked at Riverside National
- 12 Cemetery until last year, November -- actually November of
- 13 last year.
- 14 Q Okay. And you have two grown children now?
- 15 A Yes, I do.
- 16 Q And you put both of them through college?
- 17 A Yes.
- 18 Q One of them is --
- MS. WILKENS: Your Honor, I'm going to object. I
- 20 don't -- I don't think this is relevant.
- 21 THE COURT: Sustained.
- MR. ALEXANDER: Well, somebody's going to have to
- 23 assess the gentleman's credibility, and I think this is
- 24 appropriate.
- THE COURT: Sustained.

- 1 MR. ALEXANDER: All right. Thank you.
- 2 BY MR. ALEXANDER:
- 3 Q And now, finally, Mr. Ward, you mentioned -- you made
- 4 reference on several occasions in response to questions from
- 5 Ms. Wilkens about the governor signing something to stop the
- 6 execution.
- 7 A Right.
- 8 Q Are you referring to the event of stopping the
- 9 execution, whether it was the governor or a court?
- 10 A I remember it being the governor. He had just taken
- 11 office, and there were some actors -- activists and actors
- 12 that were asking the governor to stop the execution, and I
- 13 watched that on TV. He hadn't made a decision. When he
- 14 made that decision to stop the execution, I came forward.
- 15 called up to try to contact you and the defense attorneys.
- 16 Q Right. And you were never able to do that?
- 17 A No.
- 18 Q Okay. If -- if I represent to you that the governor
- 19 actually allowed the execution to go ahead, does that
- 20 refresh your recollection that your source may have been
- 21 elsewhere about the stopping of the execution?
- 22 A No. I do remember the governor signing something to
- 23 stop the execution.
- MR. ALEXANDER: Okay. Very well. No further
- 25 questions. Thank you very much, Mr. Ward.

       Good afternoon. My name is Ali Kazemi, and I represent
```

- 1 Kevin Cooper. We have never met before, is that correct?
- 2 A No.
- Q Okay. Mr. Mansfield, when did you first hear about the
- 4 Ryan/Hughes murders? When did you first hear about the
- 5 Ryan/Hughes murders?
- 6 A On TV.
- 7 Q On TV? Do you recall a specific date?
- BANO.
- 9 Q No. Do you recall how soon after the murders occurred
- 10 you heard about the murders?
- 11 A I guess right after.
- 12 Q Within a day?
- 13 A I'm sure, yeah.
- 14 Q Okay. Where were you when you learned about the
- 15 murders?
- 16 A I was probably sitting in a bar.
- 17 Q In a bar. Do you recall how you learned about it? You
- 18 just saw it on a television program?
- 19 A Yeah, it was on TV, and everybody was talking about it.
- 20 Q Okay. And who else was with you at the time?
- 21 A I couldn't tell you. It was years ago.
- 22 Q Fair enough. The day before you learned about the
- 23 murders, you were at the Canyon Corral Bar?
- 24 A I was there just about every day.
- 25 Q Just about every day. And do you recall what specific

- 1 day that was? Do you have any idea was it a --
- 2 A No.
- 3 Q -- Friday, Saturday, Sunday? No recollection. Did you
- 4 consider yourself a regular at the bar?
- 5 A Yes.
- 6 Q And about how often did you go there?
- 7 A Every day.
- 8 Q Every day. Did you ever help out at the bar from time
- 9 to time?
- 10 A Yeah. I was a bartender.
- 11 Q You were a bartender. Make sure there wasn't any
- 12 trouble, served some drinks, that sort of thing?
- 13 A Yeah.
- 14 Q Okay. And the day before the murders, do you recall
- 15 approximately what time you arrived at the bar?
- 16 A No.
- 17 Q No. This is a long time ago?
- 18 A Yeah.
- 19 Q Okay. Do you recall if it was in the morning, early
- 20 afternoon?
- 21 A I couldn't tell you. Usually went in there after work.
- 22 Q Okay. Was it daylight, was it night time?
- 23 A I'm sure it was daylight.
- 24 Q Daylight. Do you recall who else was at the bar with
- 25 you that time, any names?

- 1 A Probably the regulars.
- 2 Q The regulars, and who were some of those people?
- 3 A David Douland (phonetic), Mike Douland, my Uncle Don.
- THE COURT: Uncle Don is?
- 5 THE WITNESS: Donald Callaway, my uncle. BB Backo
- 6 (phonetic), Bob Betancourt, you know --
- 7 BY MR. KAZEMI:
- 8 Q Okay. And you said you used to bartend occasionally?
- 9 A Yeah.
- 10 Q And who were some of the other bartenders?
- 11 A My ex-girlfriend, Lynn.
- 12 Q Uh-huh.
- 13 A I believe there was Big Al, Dominique. I --
- 14 Q Okay. Does the name Ed Lauko sound familiar?
- 15 A Who?
- 16 Q Eddie, Fast Eddie?
- 17 A Oh, yeah.
- 18 Q Okay. Can you -- can you describe Big Al, please?
- 19 A Big Al?
- 20 Q What did he look like?
- 21 A Great big teddy bear Al.
- 22 Q Was he African-American, caucasian?
- 23 A He was white, American.
- 24 Q White. Do you recall some of the waitresses that
- 25 worked at the Canyon Corral?

- 1 A Oh, yeah.
- 2 Q Any names?
- A Lynn Platt (phonetic) was my ex, Jennie McNeal, who's
- 4 married to my brother now. There was Marcia. I don't know
- 5 her last name. It was so long ago, Diane. That's about all
- 6 I can remember.
- 7 Q Okay. Fair enough. Now, the day before the murders
- 8 you said you were in the Canyon Corral Bar, you recall being
- 9 in there?
- 10 A I'm sure I was there.
- 11 Q Okay. Do you recall anything unusual happening that
- 12 day?
- 13 A Not really. I mean, when I thought back about what
- 14 somebody called me and asked me about, it was afterwards.
- 15 Q Uh-huh. And what did you recall?
- 16 A Just a couple of guys that came in with smocks on that
- 17 worked -- looked like they worked at a slaughter house.
- 18 Q Okay. Can you describe those guys briefly, race, age?
- 19 A Couple of Hispanics.
- 20 Q Hispanic guys. What color hair did they have?
- 21 A Dark.
- 22 Q Dark hair, okay. And you said they were wearing
- 23 smocks?
- 24 A Yeah.
- 25 Q Okay. And do you recall approximately what time of day

- 1 those guys came in?
- 2 A No.
- 3 Q Do you remember if it was daytime or night time?
- 4 A It was daytime.
- 5 Q Daytime, and how do you know that?
- 6 A Because when the door opens, the light comes in and
- 7 everybody turns their head and looks.
- 8 Q Okay. So daytime meaning between -- between 12:00 and
- 9 7:00 would you say?
- 10 A Oh, yeah.
- 11 Q Yeah. Did a band ever play at the Canyon Corral Bar?
- 12 A Yeah.
- 13 Q Yeah. And do you recall what time the band would
- 14 usually play?
- 15 A No, not really. It's -- I imagine it started around
- 16 6:00 and would play on.
- 17 Q Now, the gentlemen who came in, the two Hispanic
- 18 gentlemen that came in --
- 19 A Pardon me?
- 20 Q The two Hispanic gentlemen who came in, was that before
- 21 the band had been playing?
- 22 A Yeah.
- 23 Q Yeah. Okay. And approximately how long would you say
- 24 that these men were at the bar?
- 25 A They didn't come up to the bar.

- 1 Q They didn't come into the bar?
- 2 A I mean up to the barstool area.
- Q Okay. How long do you think they were in the
- 4 establishment?
- 5 A I couldn't tell you. They walked by and went and sat
- 6 down.
- 7 Q Did you notice anything they were doing or anyone they
- 8 were talking to?
- 9 A No, I didn't pay any attention to them after they
- 10 walked by.
- 11 Q Okay. Do you have any idea what time they left?
- 12 A No.
- 13 Q So you basically -- you saw these guys come in and
- 14 then --
- 15 A That was it.
- 16 Q Okay. And what struck you as unusual about them was
- 17 the smocks?
- 18 A Yeah.
- 19 Q Okay. And what about the smocks was unusual?
- 20 A They just -- you know, when you walk into a restaurant
- 21 or bar, you don't wear your bloody work clothes.
- 22 Q Okay. And, again, just to repeat, you said this was
- 23 during the day that --
- 24 A Yes.
- 25 Q -- these gentlemen came in? How long were you at the

- 1 Canyon Corral that day?
- 2|A Couldn't tell you that. You mean how -- that day? I
- 3 couldn't tell you. I don't even know what day of the week
- 4 it was.
- 5 Q Okay.
- 6 A Usually I got -- when I got off work, I went there and
- 7 sat there until closing time, and I worked weekends.
- 8 Q So generally you would stay until closing time?
- 9 A No, not during the week.
- 10 Q Not during the week? Do you have any idea on that day
- 11 if you had stayed relatively late?
- 12 A No, I don't recall.
- 13 Q No recollection. Do you recall anything else unusual
- 14 happening that day?
- 15 A No.
- 16 Q So the unusual event you recalled was two Hispanic guys
- 17 coming in during the day with smocks on?
- 18 A I guess it's unusual.
- 19 Q Okay. Your mother is Shirley Killian?
- 20 A Yes.
- 21 Q And are you aware that she testified before this Court?
- 22 A Yes. She -- I was in County Jail. She said she had
- 23 come down to San Diego, said it was a waste of time.
- 24 Q Okay. Do you recall whether she was at the bar that
- 25 night?

- A I couldn't tell you.
- 2 Q Couldn't tell. Your brother, Larry, any idea if he was
- 3 at the bar that night?
- 4 A No. My older brother really didn't frequent the bar.
- 5 Q Okay. And Larry's wife, Virginia McNeal?
- 6 A Yes.
- 7 Q Any idea if she was at the bar that night?
- 8 A I couldn't tell you.
- 9 Q Okay. Were you ever interviewed by any police officers
- 10 about the events that occurred?
- 11 A Never.
- 12 Q Are you aware if Larry or Virginia or Shirley were ever
- 13 interviewed to the best of your recollection?
- 14 A I know my mother was.
- 15 Q You know your --
- 16 A Well, I don't know if she was interviewed. I know she
- 17 had to come down here a couple of months ago I guess it was.
- 18 Q Okay.
- 19 A That's -- you know, she just said in her letter when I
- 20 was in County Jail that she had to come to go to San Diego
- 21 and she saw Big Al and Kathy Royals and what a mess, she'll
- 22 tell me about it later.
- 23 Q Okay. Did you ever speak to your mother about the
- 24 incidents at the Canyon Corral that night?
- 25 A No.

- l Q Larry?
- 2 A No. What do you mean incidents?
- 3 Q Anything that you saw that night?
- 4 A No.
- 5 Q No.
- 6 A I didn't even -- I'm sure we all talked about it. You
- 7 mean what I saw? Not that I recall, no.
- 8 Q Did they ever tell you anything about what they may
- 9 have seen?
- 10 A No.
- 11 Q No. And the same applies for Virginia?
- 12 A No. My sister-in-law and I didn't really actually get
- 13 along too well at the beginning.
- 14 Q Okay. Have you ever been contacted by anyone else in
- 15 connection with your testimony today?
- 16 A Some lady on the phone wanted to know.
- 17 Q Was that Barbara Shakowsky, a California agent --
- 18 A Yeah.
- 19 Q -- Department of Justice?
- 20 A The lady said she was with the Office of the Attorney
- 21 General.
- 22 Q Okay. Have you spoken to anyone else in connection
- 23 with this either before or after?
- 24 A No.
- 25 Q And were you given any materials to review prior to

- 1 your testimony today by anybody?
- 2 A No, I didn't, no.
- 3 Q You didn't review any documents or --
- 4 A No.
- 5 Q -- testimony?
- 6 A I haven't seen none. They keep me away from everybody.
- 7 MR. KAZEMI: Okay. One moment, your Honor.
- 8 (Pause.)
- 9 BY MR. KAZEMI:
- 10 Q Just a few more questions.
- 11 A Sure.
- 12 Q You had mentioned Don Callaway.
- 13 A Uh-huh.
- 14 Q Do you have any idea where Don is today?
- 15 A My uncle passed away.
- 16 Q Okay. And Lynn you had also mentioned was --
- 17 A Lynn Platt.
- 18 Q Uh-huh.
- 19 A Yeah.
- 20 Q Do you have any idea where she is today? No?
- 21 A No. She married somebody as far as I know.
- 22 Q Okay. Just a few more names, Dominique or Dominick?
- 23 A Dominique.
- 24 Q Uh-huh.
- 25 A Dominique is -- I -- Dominique works or owns the

- 1 Taylor's Cafe in Chino now as far as I know. I saw him in
- 2 there. I stopped in there a couple of times this year

- 4 Q And Marcia or Diane?
- 5 A Marcia is -- far as I know she's still married to Fuzz
- 6 or that's what I always called him. I don't know where they
- 7 live.
- 8 Q Do you know Marsha's last name?
- 9 A Fuzz and Marcia, no, I don't. I always -- sorry.
- 10 Q And the same for Diane, do you know her --
- 11 A Diane lives in New York.
- 12 Q And do you know her last name?
- 13 A Diane and Richard, no, I don't.
- 14 Q Did I ask you Mike Douland?
- 15 A Mike Douland?
- 16 Q Uh-huh.
- 17 A Mike and Dave Douland, I only saw them at the bar and,
- 18 you know, played horse shoes with them, went riding with
- 19 them a few times.
- 20 Q Any idea where he is?
- 21 A No.
- 22|Q Okay. You said you didn't know Fuzz -- where Fuzz was?
- 23 A No. Last I heard, him and Marcia bought a house up in
- 24 the new part of Chino Hills.
- 25 Q Do you know Fuzz's last name?

- l A No, I don't.
- 2 MR. KAZEMI: Okay. No further questions.
- MS. WILKENS: Thank you, your Honor.

CROSS EXAMINATION

- 5 BY MS. WILKENS:
- 6 Q Mr. Mansfield, you said that you would arrive at the
- 7 bar after work. Where were you working in June of 1983?
- 8 A I was either working for -- in '83 it was either Foltey
- 9 Home Corporation or Barrett Homes.
- 10 Q And did you work on the weekends?
- 11 A Sometimes.
- 12 Q Okay. And do you know what time you normally would get
- 13 off work?
- 14 A 3:00, 3:30.
- 15 Q All right. And how long before you would show up at
- 16 the bar after you got off work?
- 17 A Work to the bar.
- 18 Q You'd go directly to the bar?
- 19 A Yeah.
- 20 Q Okay. So you'd usually arrive by 4:00?
- 21 A Yeah.
- 22 Q Okay. And was there a television set in the bar?
- 23 A Yeah, there's a big screened.
- 24 Q Okay. Back in June of '83?
- 25 A I believe so, yes.

- 1 Q Okay. And you indicate that you would work as a -- a
- 2 bartender on weekends sometimes?
- 3 A Yes.
- 4 Q Okay. Do you know how often you tended bar?
- 5 A Every weekend.
- 6 Q Every weekend?
- 7 A Uh-huh, Friday nights, Saturday nights, and Sunday
- 8 days.
- 9 Q And that would have been in June of '83?
- 10 A That I couldn't tell you. I don't remember if I was
- 11 working there at the time or not.
- 12 Q Okay.
- THE COURT: Did you say Saturdays and Sundays, not
- 14 Fridays?
- THE WITNESS: I worked Friday night from 6:00 p.m.
- 16 until closing, Saturday night 6:00 p.m. until closing, and
- 17 then 6:00 o'clock Sunday morning until 6:00 o'clock Sunday
- 18 night.
- 19 BY MS. WILKENS:
- 20 Q All right. But you're not sure if you were working as
- 21 a bartender then?
- 22 A I -- no, I don't.
- 23 Q Okay. Do you know how many bartenders used to be on
- 24 duty on a Friday or a Saturday night?
- 25 A On weekends there was two.

- 1 Q Okay. You -- you indicated that the two Hispanic males
- 2 that you saw had bloody work clothes. You --
- $A \rightarrow Just liked they worked in a butcher shop. They had,$
- 4 you know, the smock on. You know, it was just like blood
- 5 right here in the belly area.
- 6 Q Okay. And when you say a smock, did it have like a tie
- 7 and you'd wear it over your garments?
- 8 A It was like, you know, one of them smocks you just wear
- 9 over and tie behind.
- 10 Q Okay. And you didn't think it was unusual to -- to see
- 11 someone in a smock?
- 12 A I -- I thought it was unusual for them to come in to,
- 13 you know, eat or whatever they're going to do. It looked
- 14 like they can just take them off.
- 15 Q Okay.
- 16 A But there's -- you know, there's slaughter houses in
- 17 Chino. I didn't really pay much attention.
- 18 Q Okay. So there -- there are slaughter houses in Chino?
- 19 A Yes.
- 20 Q And how close are they to the bar?
- 21 A Couple three miles I guess.
- 22 Q Do you know how many slaughter houses there are, more
- 23 than one?
- 24 A I'm sure.
- 25 Q Okay. And that was in June of 1983?

- 1 A Uh-huh.
- THE COURT: Is that a yes?
 - THE WITNESS: Yes.
- 4 BY MS. WILKENS:
- 5 Q Now, you indicate that when you saw these two Hispanic
- 6 males come into the bar that it was daylight outside, is
- 7 that correct?
- 8 A Yes.
- 9 Q All right. And you're positive that it was daylight?
- 10 A Yes.
- 11 Q Okay. Now, you indicated that they both had brown
- 12 hair, is that correct?
- 13 A The best I can recollect, yes.
- 14 Q Okay. Do you recall the length of their hair?
- 15 A Short. I mean --
- 16 Q Would it be a crew cut?
- 17 A I -- crew cut -- I guess. I don't know. Like his but
- 18 shorter than that.

- 19 A I might have. I can't recall.

- 10 Q All right. So you thought about it after Mr. Cooper
- 11 had been apprehended?
- 12 A Yeah, because then I -- I think I said, well, it
- 13 couldn't have been them other two guys.

- 16 A Yeah, because the more I thought about it, I was trying

- 7 convicted of grand theft in May of 2004?
- 8 A Yes.
- 9 MS. WILKENS: Okay. Your Honor, I have no further

- 12 REDIRECT EXAMINATION
- 13 BY MR. KAZEMI:
- 14 Q Mr. Mansfield, do you know where Al Ward is right now?

24 so that we can look at Doctor Ballard's methodology, but I
25 don't want -- I don't want it said that the methodology we

1 present is Doctor Ballard's without knowing that, and I also want to have preserved in the record what, in fact, his 3 methodology is because I'm concerned that at some point he's in a Cafford (phonetic) seat criticizing what we're bringing 5 forward and we have no idea and cannot discern that later 6 independently what his methodology was.

THE COURT: But can you have it both ways? 8 Court has said at least at this time with the pending motion 9 for reconsideration that he's not to be involved, do you 10 want that for purposes of the record to show that it is 11 scientific and valid? I mean, is there any problem with 12 filing that under seal?

13 MR. ALEXANDER: It seems to me, and I -- it seems 14 to me that that -- that I could persuade Doctor Ballard and 15 the people he has to report to who are really making this 16 kind of decision that if it's simply filed with your Honor, 17 with the Court, and not accessible to the other side, that 18 that's not a problem, and I agree. I think it's a good idea 19 for Mr. Sciudak to do the same, and we won't see it, and the 20 Court can decide what it wants to do.

I would also add to that request a piece of 22 information I -- I ask. First of all, I don't know whether 23 or not -- I read Mr. Sciudak's curriculum vitae, and I don't 24 know whether he's done any EDTA testing at all before, let 25 alone in a capital case, number one. Maybe he could

1 answer -- we could answer that. I think that would be 2 important to know.

And, secondly -- and I don't think this requires 4 being under seal, but if he feels it needs to be, there is 5 an issue about the particular type of variant of EDTA I 6 think that's going to be used, and I may -- I may be 7 mistaken, but in my first conversation with him, he 8 recognized that something called deuteronium, D-E-U-T-E-R-O-9|N-I-U-M, would not be acceptable and that you'd have to go 10 to carbon 13, and the question is where would they get the 11 carbon 13 from or would they have to synthesize it. an important aspect. We're not aware of it being commercially available. Perhaps it is. So that's a 13 14 question that maybe he could also provide. I mean --THE COURT: Okay. Your expert, the one that you

16 have, what would -- what role would that person play? MS. WILKENS: Doctor Sciudak or Doctor Lee?

THE COURT: No, Doctor Lee.

1 wouldn't be asking for Doctor Sciudak's protocol to be under 2 seal. He does not have any proprietary concerns. 3 asking to preserve in time Doctor Ballard's methodology.

And one thing I should say is it should include every pertinent detail that an analytical chemist should 6 need because if it's very perfunctory and lacking in detail, 7 then presumably it won't be part of Doctor Ballard's 8 methodology because at some point they're going to be 9 critiquing Doctor Sciudak's methodology, and at some point 10 the Court may want to issue a protective order and work with 11 Doctor Ballard's methodology, and we don't want it where we can't have our experts reviewing his methodology under -under a protective order because particularly when it hasn't 14 been subject to peer review, should the Court decide to 15 involve Doctor Ballard or his methodology, we would 16 obviously want Doctor Lee reviewing it for its scientific 17 validity.

Well, let me say one idea that the THE COURT: Court had was to have the -- to say what -- for the Court to say what should be determined and some control areas and 21 then have a separate shirt that is also -- so we send it off to Doctor DeForest. They pull off those areas. 23 the samples ready to be tested, and then we have two 24 separate controls, one with a T-shirt that's already been 25 washed with blood on it and have a control area there so

1 that it's marked in various vials not known to the testers, 2 then shipped off to let's say Doctor Sciudak. He performs 3 his results with the expert observing from the Petitioner's 4 side, and then those are remarked -- if there's a way to 5 preserve that so that they're remarked and then shipped to 6 the Petitioner's expert, whether it be Doctor Ballard or 7 otherwise, and with Doctor Sciudak observing, theoretically, 8 so you've got two different controls. They don't know which 9 is the evidence and which is the control, and theoretically 10 the test should be the same.

MS. WILKENS: Well, your Honor, the -- I know -- I 12 noticed yesterday your Honor was thinking that it would 13 elevate the testing to do double blind testing. 14 increases the time, and it increases the cost, and the sole 15 purpose is because of the concerns about Doctor Ballard. 16 If -- if you have confidence in the scientist, then you 17 don't need to have purportedly blind testing, and we don't 18 feel it's necessary to go through a double testing, and we 19 also continue to object to any testing by Doctor Ballard or 20 by his lab.

And, frankly, I have concerns about Doctor 22 DeForest because he's almost become an advocate in terms of 23 how he's been calling our lab, trying to get them to agree 24 to -- you know, he was involved in Pompay. I really would 25 appreciate it if they would get a criminalist in the State

1 of California. It would be nice if they used the same 2 criminalist they used last time rather than disavowing 3 themselves of their various choices over time, but I 4 don't -- I don't think it's worth the expenditure of both 5 time and money in order to involve Doctor Ballard in the 6 process because that's where the double blind testing has 7 been interjected.

And with respect to controls from --

THE COURT: Then on appeal, certainly an issue for 10 the Petitioner would be that they wanted this certain expert 11 and the Court denied this certain expert. And so if he is a 12 participant in some way with additional -- with the 13 additional control that we have another person that is 14 observing and another person that's doing a similar test, 15 then the test results should be the same. If they're 16 dramatically different, then that speaks volumes to the 17 reliability of the EDTA testing.

MS. WILKENS: Well, it'll speak volumes. 19 don't know which way it will go. And -- and, again, they don't -- they don't have a right to have Doctor Ballard perform the testing. If they want to have Doctor Ballard 22 observe and if Doctor Ballard wants to be their expert, I 23 suppose there's nothing, you know, to be said about it. But 24 for him to be performing the tests on this evidence is -- is 25 inappropriate because of his baggage.

Well, Mr. Alexander? THE COURT: 1 MR. ALEXANDER: I've not felt very good about the 3 continuing shots at Doctor Ballard. I'll leave that alone. 4 I think Ms. Wilkens is poorly placed to make those 5 accusations, but when you now start to take the same shots 6 at Doctor DeForest who I can tell you is a man of impeccable integrity and credentials and he'll come here if that's 8 necessary --THE COURT: We're already -- we're already -- he's 10 already --MR. ALEXANDER: He's not an --11 THE COURT: -- done work. 12 13 MR. ALEXANDER: -- advocate one way or the other. 14 He is the most conservative individual with impeccable 15 integrity, and I just wish this sort of stuff would stop. THE COURT: Uh-huh. 16 17 MR. ALEXANDER: Now, I think the double blind 18 testing makes sense, and we're -- we're certainly amenable to it, and I don't know whether Mr. Sciudak has ever done 19 20 this before. That would be helpful to know. we'll -- we'll find out. THE COURT: And I think that's -- that's a fair --22 MR. ALEXANDER: Okay. I mean, I read the articles 23 24 and, you know, after trying to pronounce the words, I 25 couldn't tell whether any of this has to do with the kind of

1 EDTA testing we're -- we're involved -- we're involved in. Okay. 2 THE COURT: MR. ALEXANDER: And I've actually asked Doctor 3 4 DeForest just to look at the resume and see if he has any idea. Obviously the gentleman's, you know, very --THE COURT: Is very qualified. MR. ALEXANDER: -- appears to be very well 8 qualified, it seems, from what we can read on paper, bit of 9 an attitude, but that may be it was just he and I. I don't 10 know, and he won't talk to me. So I would -- and if they want to use Doctor Lee 11 12 for whatever purposes, I guess I can't stop that. THE COURT: Well, why don't you contact Doctor 13 14 Ballard, see if he's willing to provide the protocol under 15 seal. MR. THE COURT: Then you -- then you have it done 4 without observation.

MS. WILKENS: No. We'll have to pay someone, but 6 that's my point. You know, if you send it back to the east 7 coast, the expenses are raised. And, once again, they have 8 been ordered to find someone besides Doctor Ballard and 9 someone besides Doctor Ballard's lab, and I think they 10 should be able to do that, and if you want to have double 11 blind testing, they should have a laboratory and an expert 12 that is not Doctor Ballard and not National Medical 13 Services, and we will continue to object to this evidence 14 being examined by a junk scientist at a laboratory where we 15 have bona fide concerns.

THE COURT: Well, I think we've already discussed 17 that if the expert comes with -- with some issues raised 18 about the scientific method, then whatever is done still has 19 those issues above the scientific method.

On the other hand, Petitioner has the right to 21 decide who in the nation may or may not be able to do that 22 and would want somebody who's got credentials to do that and 23 would not necessarily want the Government or the Court 24 picking the expert to do it.

So the Court's balance in this respect would

1 require some additional costs but with the benefit of some 2 additional observation. And so I'll ponder these issues and 3 then hopefully by tomorrow we'll come up with some order, 4 and then the parties can proceed. 5
