Re: Petition for Executive Clemency Filed on Behalf of Death Row Inmate Kevin Cooper

Dear Governor Brown:

We are filing today with this letter a Petition for Executive Clemency and related documents and exhibits on behalf of our client, Kevin Cooper.

We recognize these materials are voluminous and wish to ensure the greatest ease of review for you and your clemency staff. To streamline such review, we have provided the following materials:

- (1) Application for Executive Clemency, signed by Mr. Cooper, and the Notice of Intent to seek Executive Clemency served by my office upon San Bernardino County District Attorney Michael Ramos.
- (2) An original Clemency Petition and four (4) hard copies of the Clemency Petition, spiral bound. The original and these copies each include a disk containing the Clemency Petition and live links¹ to the exhibits to the Clemency Petition for easy reference.
